About the Electrical Industries Charity (EIC)

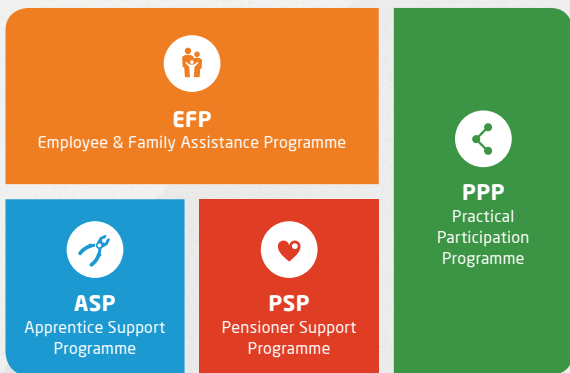
An industry charity for industry people

Eligibility criteria

- Majority of work history must have been within the UK
- Those in the same household and who are related to the eligible party will be considered for support
